**Minutes of Meeting Held

APHA CONVENTION: Jennifer Mendes attended the convention as a director for California. She gave an oral report. Some of the highlights – Rule proposal that management and their family could not show at a show they were managing. This rule did not pass. Amateurs could get paid for giving lessons just not at a show. This rule did not pass. Amateurs could get money or product for advertising. This rule did not pass. Show results now have to be into APHA within 10 days of end of show. In the amateur walk/trot class 2 hands can be used in riding (Split reins, etc.) Also they are starting a certification class for show secretaries.

YEAR END AWARDS: Janet reported she is using a new vendor – Studio B- and giving gift certificates to have a drawing of your horse or dog. She showed the group some samples and everyone thought they were beautiful.

NEW BUSINESS:

We checked our by-laws and it doesn't look like we need to change anything. The topic of having zoom meetings was brought up but no one thought that was necessary. The next meeting after the show will be a general in-person meeting. Time and date will be announced later.
